#### The Irish Festival of Oulu

### September 30th to October 3rd 2010

The 5th anniversary Irish Festival of Oulu, September 30-October 3, once again brought the City of Oulu a wide range of cultural activities that attracted 8,000 people. Fans came not only from the Oulu area but from all over Finland and from as afar afield as Ireland, France, Denmark, and Russia. The weather was sunny and ideal for the 4-day festival weekend. The festival welcomed distinguished guests including Irish Ambassador to Finland Dermot Brangan and Comhaltas Director Vince Hearns.

Irish Film Week II was expanded to include 23 films, including a wide variety of documentaries, a live concert, and a collection of award winning Irish short films. The film week's main attraction Gabriel Byrne - Stories From Home was screened in Valve Concert Hall to a crowded audience of 108 people. Director Pat Collins hosted questions and discussions immediately following the film.

The festival expanded its cultural activities into theatre offering 2 stellar performances of Tom Crean – Antarctic Explorer, written and performed by Aidan Dooley. Attendance was great on both nights and Aidan received his first ever standing ovation for the Saturday night performance, which received a great review by Kaleva newspaper the following day stating, "the festival can be proud for successfully extending its programme into theatre."

### **Order of Merit**

Plans are well under way to institute a new Clans of Ireland Order of Merit which will be awarded to individuals who have made a sustained and significant contribution to Irish culture and heritage. Any clan who has been registered for 3 consecutive years will be able to nominate someone to receive the award and a sub committee established to co-ordinate the Order of Merit will make the final decision. Nomination forms will be made available in due course in the members section of the Clans of Ireland website.

### Charitable Status

We are delighted to announce that we are now in a position to extend our charitable status to cover all Clans with a permanent address in Ireland. Such clans can use the Clans of Ireland charitable status number to collect funds for educational and cultural purposes without creating a tax liability. Those Clans who wish to use the Clans of Ireland charitable status number will be obliged to maintain accounts for inspection by the board of Clans of Ireland as requested.

We have applied for funding from the Heritage Council to commission research on the concept of kinship and Clans in Gaelic Ireland up to the present day. It is our hope that this research will be useful in providing a scholarly basis upon which Irish Clans can continue to develop into the future.

### Father John Francis Cassidy,

John Francis Cassidy was born in Melbourne, Australia, in September of 1841, and arrived in America with his parents as a child. He entered the North American College in Rome from the San Francisco Archdiocese in 1859.

He was ordained in Rome in June 1865, just 24 years old.

He was named second pastor of St. Leander's Church in San Leandro. He served in the same capacity in San Andreas in the Mother lode country. In 1875 he was appointed pastor of St. Joseph's Mission San Jose, from where he served the mission church until he arrived in Livermore as pastor, August 24, 1878.

For the Catholics population of the Livermore, August 25 was a very special Sunday to celebrate. They were welcoming their first pastor, Father John Francis. Cassidy to St. Michael's. No longer would they have to travel long distances for Mass or wait for the irregular visits of a mission priest. From now on a priest would be in Livermore to regularly administer the sacraments and to offer pastoral guidance.

Father Cassidy's stay here was brief, because of a fire in the little church. Early records are sparse, but we do know that Father Cassidy, for lack of a rectory, slept in the sacristy

Six months later in February of 1879, Father Cassidy was transferred to Leadville, Colorado. In 1891, plagued by illness, he went to Los Angeles, where he died May 21, 1892. He was 50 years old. A Solemn High Mass of Requiem was held at St. Joseph's in San Francisco. His old classmate, Archbishop Patrick W. Riordan gave the blessing.

Among his other classmates were also two others who would attain the distinction of becoming archbishops: Michael Corrigan of New York; and Robert Seton (grandson of Mother Seton, first US nativeborn saint, canonized in 1975 as St. Elizabeth Seton).

### **EARLY LIVERMORE**

The town, to which Father Cassidy came, was a busy and growing place. The Catholic people who welcomed Father Cassidy in 1878 had been settling in Livermore in the 1850's and 1860's. Many were Irish, seeking relief from the potato famine that was causing widespread economic disaster in Ireland. Some Italians and Portuguese came during that time. They all joined the few of the h3ish heritage who were already here. These families lived a hard life, often working from sun up to sun down, enduring droughts and storms and the loss of crops and livestock. Through it all, their strength and their refuge was in each other and in their religion. For these early settlers, attending Mass meant a long, tiring trip.

In the 1870's more Catholics came, some directly from Ireland, some from other parts of the United States. The 1870's also brought Catholics from continental Europe.

After the Southern Pacific Railroad came through in 1869, buildings began to spring up around the railroad station (which at first was just a freight car). Ranching and farming were the principle livelihoods for most people, but small businesses also started in town. In 1874, a fire company, the Hook and Ladder #1 was formed. The firehouse was built on Second Street. Well water was used until John Aylward formed the Livermore Spring Water Company in 1875. In 1876, Thomas Hayes brought water from Las Positas Creek in two-mile long flumes. Workers on these flumes sometimes would get inebriated to the point where a marshal was hired at \$50.00 a month and a wooden jail was built. Those who couldn't stagger to the jail were delivered there by wheelbarrow. In 1876 Livermore had sufficient population, around 800, to incorporate as a town. The town was a mile and a half square, with street widths wisely decreed at 80 feet. The newspaper of the day was The Enterprise, published by W.B.Bartlett, the forerunner of the Livermore Herald.

Today, The city of Livermore (pop. 83,604) encompasses twenty-two square miles and is the easternmost city in the San Francisco Bay Area and the Livermore Valley played a pivotal role in shaping California's wine industry and is considered one of California's oldest wine regions. It has become an integral part of the Bay Area, successfully competing in the global market powered by its wealth of research, technology and innovation.

It also has an area called **Dublin** 



# Cassidy Musicians

In previous Cassidy Clan Newsletters we have written a great deal about Na Casaidigh, The Cassidy Family. We would now like to expand the research on other renowned Cassidy Musicians.

### **Con Cassidy**

Traditional Fiddler 1909 - 1994

Con Cassidy was born on the 6th of July, 1909 in Teelin, Co. Donegal in the parish of Glencolmcille.

Con's parents were Frank Cassidy and Mary Haughey. Although they did not play music, they were very fond of it. From about the age of nine years, Con used to visit the house of a neighbour, Paddy Barron. Paddy played the fiddle and it was a tin fiddle that Paddy had. This was very common at the time in this area. (The Mc Connells & The Dohertys were travelling tinsmith families who were good musicians, mainly fiddlers, and they made a lot of tin fiddles, which were cheap to buy and were easy to get. They were literally delivered to your door). Con used to visit Paddy Barron's house almost every day and would be allowed to have a go at Paddy's tin fiddle. He was largely self-taught. In

1924 Con's sister, Mary Cassidy, was working in Letterkenny. She came across a shop that sold fiddles and she wrote to her father with the details of the price and delivery details. Soon after that Con got his own fiddle in the post.

Like many from the area, Con had to go away to get work. He worked in England for a time as a general labourer. Con was married in England to a girl from his own area, Mary Kate Mc Brearty.

They returned to Teelin soon after that

John Doherty lived in Carrick for a time in the 70's and Con used to play with John often in those days. There was a great increase interest in the music of that area in the late 70's.young fiddle players such as Dermot Mc Laughlin, Máiréad Ní Mhaonaigh, PaulO'Shaughnessy, Máire O'Keeffe, Maurice Bradley and others came regularly to visit, play with and learn from Con.

Con Cassidy died in 1994.

The other fiddle playing Cassidy's of Teelin, were, Johnny, Paddy and Frank Cassidy cousins of Con's

## **Tommy Peoples**

Another member of this distingushed musical family is

Tommy Peoples who's mother was a Cassidy. He was born near St. Johnston, Co. Donegal in 1948. He has been a member of well known traditional Irish music groups, including 1691 and The Bothy Band as well as performing solo since the late 1960s. He moved to Dublin in the 1960s. where he became involved in the traditional music scene.

His contemporaries of that period included Sean Keane and Matt Molloy of the Chieftains, Liam O' Floinn of Planxty, Paul Brady and Mary Bergin.

Tommy's first commercial recording was done for Comhaltas, the Irish traditional music organization. This recording consisted mostly of live performances in folk clubs etc. and was recorded around 1969 He subsequently moved to County Clare and married Mary Linnane, daughter of Kitty Linnane, long-time leader of the

Kilfenora Céilí Band and was a member of the band for a number of years. He now resides in his native County of Donegal. His daughter Siobhán Peoples is a noted fiddler in her own right.



Tommy also won the title "Fiddler of Oriel" in Monaghan in 1970

Two members of the Cassidy Clan Exec. Committee were founder members of this long running festival---Nuala Cassidy White and Noel Cassidy.

The pedigree associated with previous champions, insures that, the "Fiddler of Oriel" title remains one of the most prestigious and recognised accolades in Irish traditional music today.

# Theodore Crawford Cassidy 1932 - 1979

**Theodore Crawford Cassidy** (July 31, 1932 - January 16, 1979), known as **Ted Cassidy**, was an American actor and voice actor who performed in television and films. Extremely tall at 6 ft 9 in (2.06 m), he to play unusual characters Although born in Pittsburgh, Cassidy was raised in Philippi, West Virginia, 120 miles south of Pittsburgh. Early in his academic career, Cassidy attended West Virginia Wesleyan College, in nearby Buchannon, WV, where he was a member of Alpha Sigma Phi Fraternity. He later attended Stetson University in DeLand, Florida, as a Speech major. Upon graduation with a degree in speech and drama, he married Margaret Helen in 1956, and they moved to Dallas, Texas. In 1957, Margaret gave birth to their son, Sean, and in 1960 daughter Cameron was born.

### **The Addams Family**

Cassidy's unusual height gave him an advantage in auditioning for unusual character roles. He is probably best known for playing the tall butler, Lurch and the "helpful hand in a box" character named Thing, on the 1960s American television series The Addams Family. It was Cassidy who came up with the "You rang?" line, which was so funny that it was incorporated in the show, where the Lurch character had originally been intended to be nonspeaking.

### **The New Adventures of Huckleberry Finn**

Cassidy had a regular role on *The New Adventures of Huckleberry Finn* as Injun Joe. the blood-foe of Tom Sawyer and Huck

### Voice acting and film work



While appearing on The Addams Family, Cassidy began doing character voices on a recurring basis for the Hanna-Barbera Studios, culminating in the role of Frankenstein Jr. in Frankenstein Jr. and The Impossibles series. He was the voice of the hero in the Chuck Menville short film "Blaze Glory (1969)" in which his already deep voice was enhanced with a deep reverb & echo to give the character an exaggerated super-hero sound. Cassidy also voiced Ben Grimm aka The Thing in the 1978 animated Fantastic Four. Cassidy went on to perform the roars and growls for Godzilla in the 1979 cartoon series that Hanna Barbera co-produced with Toho. His was the basis for the sinister voice of Black Manta, as well as Brainiac and several others on Super Friends.

After The Addams Family, Cassidy began to add more voice-over work to his résumé; in that acting field, most notably, he narrated the opening of the TV series The Incredible Hulk. Healso provided the Hulk's growls and roars. He was often confused with actor Richard Kiel, who played "Jaws," the assassin with stainless steel teeth, in two James Bond films.

Other film work included his appearances in Butch Cassidy and the Sundance Kid, Mackenna's Gold, Goin' Coconuts, The Last Remake of Beau Geste, Poor Pretty Eddie, Harry and Walter Go to New York, The Slams, The Limit, and Charcoal Black. He also co-wrote the screenplay of 1973's The Harrad Experiment, in which he made a brief appearance.

Cassidy suffered from health issues as he grew older, and died at the age of 46 from complications following open-heart surgery.

#### LAWS OF DESCENT AND DISTRIBUTION BEFORE 1829

Of the many laws governing wills and settlement of estates, those pertaining to the distribution of the estate are of particular interest in genealogical research. Generally, a person can name anyone in a will. There is a very good reason why it is usual to find all the legal heirs mentioned. Failure to do so can result in the will being contested. Thus, you will find bequests of \$1.00 or some reason given for not including a legal heir. Distribution of an estate is made according to the instructions in the will; however, if a person died intestate or if the will is contested and not allowed to stand, the distribution of the estate is helpful in determining the relationship of those included in the settlement. A knowledge of the laws in effect is necessary.

In South Carolina in 1712, the English Statutes were made of force. Under the provisions, the distribution of personal property was as follows:

- (1) 1/3 to the wife; the rest in equal portions to the children and such persons as legally represented such children in case said children were dead.
- (2) If no children, the widow would receive one part; the other part went to the "next kindred" but no representation among collaterals after brothers' and sisters' children.
- (3) If no wife, the estate was divided amongst the children.
- (4) If no children, the estate went to "every of the next kindred who are in equal degree". Provision was made that the distribution consider settlement made prior to the intestate's death. This was to insure that the estate was equally divided. No distribution was to be made until after one year. Real property was inherited according to the "Rights of Primogeniture". This was the Common Law-the right of the oldest son to inherit the estate (real property) of his father. Personal property was inherited according to the Statute Law outlined above. "Canons of Descent" outlined the distribution of real property if there was no living oldest son.

This method of distribution of estates continued in force until 1791 when Primogeniture was abolished. Under a new statute, the real estate was to be distributed in the same manner as the personal estate according to

the following provisions:

- (1) 1/3 to the widow; the remainder to child or children. Lineal descendants to represent their parents.
- (2) If no child or lineal descendant survived, but a widow, father or mother did--the widow received 1/2, the father 1/2. If the father was dead, the mother received his half.
- (3) If neither lineal descendants, nor father or mother survived, but a widow and brothers and sisters of the whole blood did, the widow received 1/2 and the brothers and sisters 1/2. Children of a deceased brother or sister were to have their ancestor's share.
- (4) If no lineal descendant, father, mother, brother or sister of the whole blood survived, but a widow and brother or sister of the half blood, and a child or children of a brother or sister of the whole blood did-- the widow received 1/2; the other 1/2 was equally divided between brothers and sisters of the half blood and the children of the brothers and sisters of the whole blood. The children of the deceased brother of the whole blood took among them a share equal to the brother and sister of the half blood. (See illustration below)
- (5) If no brother or sister of the half blood survived, then 1/2 went to the children of the deceased brother and sisters.
- (6) If no children of deceased brother or sister of the whole blood survived, then the  $\frac{1}{2}$  went to the brothers and sisters of the half blood.
- (7) If no lineal descendant, father, mother, brother, or sister of the whole blood or their children, or brother or sister of the half blood survived, the widow received 1/2 and the lineal ancestor the other 1/2.
- (8) If none of the above survived, the widow received 2/3; the remainder went to the next of kin. (9) If no widow survived, the estate was to be distributed as outlined above.

In reckoning degrees of kindred, the computation began with the intestate and continued to the person claiming kindred, inclusively, each step inclusively being reckoned as one degree.


On the death of any married woman, her husband was entitled to the same share of her real estate as was given to the widow out of the husband's. The remainder was to be distributed in the same manner. was given to the widow out of the husband's. The remainder was to be distributed in the same manner.

Land or personal estate acquired after the making of a will was to be distributed as under this Act. In 1808, this section was repealed, and personal property acquired after the making of a will was to pass thereby.

In 1797, an Act was passed stating that if no wife, child, nor lineal descendant survived, but a father and mother and brothers and sisters, the estate was to be equally divided. The issue of a deceased brother or sister took the share of their parent.

In 1826, an amendment stated that if there was no lineal descendant, father, mother, brother or sister of the whole blood, or their children, or brothers or sisters of the half blood, or lineal ancestor or next of kin, the widow was to take the whole estate. In the event the intestate was a married woman, her husband was to take the whole estate.

Changes have been made in the laws of inheritance since 1826. Therefore, when searching probate records for wills and estates divisions, it is necessary to understand the laws which were in force during the period you are studying.
